  - A. Three months to be considered for a MAKO Scholarship
2. Applicant must be **current member** of OCCE.
3. Applicant must demonstrate a sense of professionalism and high level of job performance.
4. Ability and willingness to pay remaining costs of the program of study.
5. Applicant should be chief executive officer or management employee who has demonstrated potential for or interest in a career in the Chamber Management field.
6. Financial need shall be considered providing above criteria are met.

**\*Requirements for Application:**

1. Complete and submit a scholarship application by deadlines below
2. Submit a letter from the chamber chief volunteer officer (if applicant is CPE) or from the CPE (if the applicant is other staff) showing a willingness of the chamber to pay remaining expenses related to program attendance.
3. Submit originals either via US Mail or e-mail. Faxes are acceptable but mail or e-mail is preferred.
4. **Attach a statement** explaining reasons for applying and career objectives (minimum 100 words).
