Chamber Management Institute (CMI)

CMI is a program for chamber executives and staff who want to gain additional insight into the roles and responsibilities of being a part of a successful chamber of commerce.

In addition to the formal classroom instruction, attendees are able to network with each other, thereby increasing their learning potential. This program provides insight into chamber overview and management issues, community and economic development, public policy, tourism marketing and membership recruitment and retention. Graduates of the program are encouraged to continue their learning by enrolling in the Institute for Organization Management sponsored by the U.S. Chamber of Commerce. Chambers of Commerce:

- **Small (Budget less than \$250,000 per year)**
\$115 Annual Membership Investment, includes one representative.
Additional representatives—\$65/ea.
- **Medium (Budget of \$250,000—\$800,000 per year)**
\$165 Annual Membership Investment, includes one representative.
Additional representatives—\$65/ea.
- **Large (Budget of more than \$800,000 per year)**
\$350 Annual Membership Investment, includes one representative.
Additional representatives—\$100/ea.

Associate Membership:

For non-chamber entities who wish to belong to OCCE, including CVBs, companies who sell products and services to chambers, etc., the fee is **\$100.00.**

Note: Membership investments are due January of each year.
